RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET NO.1 OF BARANGAY PILI, THIS MUNICIPALITY AS EMBODIED IN THEIR APPROPRIATION ORDINANCE NO. 08 SERIES OF 2015.

WHEREAS, a preliminary review was made on the Barangay Supplemental Budget No. 01 Series of 2015 of Barangay Pili, Pinamalayan, Oriental Mindoro appropriating the amount of Php 47,645.84 and Php 306,971.00 representing Unappropriated Surplus of 2014 and increase in barangay's share in Internal Revenue Allotment (IRA) for the period of January to December 2015 and realigning the continuing balances of the 10% SK Fund amounting to Php 119,179.81 and Php 21,407.10 respectively;
